

Regular Session

October 3, 2016

The Union County Board of Supervisors met in Regular Session on Monday, October 3, 2016. The meeting was called to order at 9:00 AM with the following members present: Lois Monday, Dennis Brown and Ron Riley.

**AGENDA:** Motion by Monday and seconded by Brown to approve the Agenda. All voting aye, motion carried.

**MINUTES:** Motion by Monday and seconded by Brown to approve the minutes from September 26, 2016. All voting aye, motion carried.

**OPEN FORUM:** Loretta Harvey expressed appreciation on the work that was done on Osage Street. Lennie Thompson mentioned where you can purchase river rock as an alternative. Dennis Brown informed the public that Gary Keenan, chain saw artist/carver from the Iowa State Fair, will be here sometime in November to carve an Eagle in the stump out front of the Courthouse in honor of Union County Veterans. The cost will be approximately \$1,500.00 and will be raised by donations. No County dollars will be used for this project.

**FAMILY ASSISTANCE CONTRACT AMENDMENT:** Motion by Monday and seconded by Brown to approve the DCAT5-17-018 Family Assistance Contract Pass Through Grant Amendment for \$10,000.00 for services and activities to the DHS and the JCS eligible families for children who have been removed or who may be removed and placed in relative placement, foster care, a child care setting, a group home, a juvenile detention facility, as presented by Jocelyn Blazek, DECAT/CPPC/Coordinator. All voting aye, motion carried.

**ENGINEER:** Steve Akes, Union County Engineer, presented and discussed the weekly maintenance activity report. Akes also presented a letter requesting a level C road in Pleasant Township to be reclassified from Rex Fowler. Fowler requested to gate 255<sup>th</sup> Street on P64 South of Thayer, about one mile North of Oakhill Chapel. The dirt road runs East and is an access road only to the Fowlers farm fields. Akes will check with the surrounding landowners and will bring the information back to the Supervisors. **Work within County Right-of-Way:** Motion by Brown and seconded by Monday to approve an application to perform work within the County Right-of-Way on Marks Way Road to concrete a parking area that will collect run off and direct it to a drainage ditch on property owned by Mike Tamerius, at his expense. All voting aye, motion carried. **Willow Avenue Road Closure Request:** Motion by Brown and seconded by Monday to keep Willow Avenue, in Pleasant Township, open as a Class B Road. Roll Call Vote: Brown, aye; Monday, aye; Riley, aye; motion carried.

**AUDITOR'S QUARTERLY REPORT:** Motion by Brown and seconded by Monday to accept the Auditor's Quarterly Report. All voting aye, motion carried.

**ADJOURNMENT:** There being no further business, the meeting was adjourned at 12:25 PM.
