

The Union County Board of Supervisors met in Regular Session on Monday, May 14, 2018. The meeting was called to order at 9:00 AM with the following members present: Ron Riley, Dale Cline and Dennis Brown. Also present from the Creston Community Government Class were: Ashton Carter, Sara Williamson, Trey Gift and Madison McCaulley.

**AGENDA:** Motion by Cline and seconded by Brown to approve the Agenda. All voting aye, motion carried.

**TAURUS SOW CONFINEMENT:** Dave Wittry, AMVC Management, discussed the reconstruction of the barns that were damaged in a recent fire in Section 16 of Platte Township. Before the new rule of the 100ft building distance from the right of way, these buildings were built at 45ft from the right of way. Wittry was requesting the board to sign a waiver on the distance.
