

Regular Session

June 11, 2018

The Union County Board of Supervisors met in Regular Session on June 11, 2018. The meeting was called to order at 9:00 AM with the following members present: Ron Riley, Dale Cline and Dennis Brown.

AGENDA: Motion by Cline and seconded by Brown to approve the Agenda. All voting aye, motion carried.

MINUTES: Motion by Brown and seconded by Cline to approve the minutes from June 4, 2018. All voting aye, motion carried.

OPEN FORUM: No one spoke in open forum.

ENGINEER: Zach Gunsolley, Union County Engineer, presented and discussed the weekly maintenance activity report. **Utility Permit:** Motion by Cline and seconded by Brown to approve the utility permit with H & H Commercial Services, Diagonal Iowa to install a sewer line at Summit Park Lane in Section 3 of Douglas Township. All voting aye, motion carried. **Utility Permit:** Motion by Brown and seconded by Cline to approve the utility permit with Windstream for boring into Beechwood Ave and placing 300' of new 12 pair copper cable from existing pedestal to a new pedestal at 1959 Beechwood Ave in Section 20 of Douglas Township. All voting aye, motion carried. **Utility Permit:** Motion by Cline and seconded by Brown to approve the utility permit with Windstream for placing 145' of buried fiber optic cable on REA Road. Fiber to be placed 28' from the centerline of the road at a minimum depth of 36" in Section 22 of Lincoln Township. All voting aye, motion carried.
