REGULAR SESSION

The Union County Board of Supervisors met in regular session on Monday, May 23, 2011. The meeting was called to order at 9:00 AM with the following members present: Lois Monday, Bob Brown, Bob Jansen, Dennis Brown, and Ron Riley.

AGENDA: Motion by Dennis Brown and seconded by Bob Brown to approve the Agenda. All voting aye, motion carried.

MINUTES: Motion by Monday and seconded by Dennis Brown to approve the Minutes from the May 16, 2011 meeting. All voting aye, motion carried.

PUBLIC HEARING ON BONDING: Public Hearing opened at 10:00 AM. Present was Rudy Ehm, Karon Finn, and Elaine Gordon. The Board of Supervisors received comments opposing further bonding and asking for more deliberations before voting on bonding. Ehm asked about the CF debt, interest rates, and the Cherry Street construction to the airport. Finn asked about Speer Financial's costs for doing the bonds, what the airport city grant was being used for, and the total amount bonded. Gordon asked about previous bonds. Hearing closed at 10:28. Motion by Jansen and seconded by Bob Brown to proceed with the bonding of \$500,000 for Cherry Street Road to the airport and refinancing the Series 2004 CF Processing Bond for a lower interest rate. Roll Call Vote: Dennis Brown aye, Bob Brown aye, Jansen aye, Monday aye, and Riley aye. Motion carried.

ENGINEER: Steve Akes, Steve Maltzahn, Tom Lesan, Doug Jones, and Mark Roberg discussed the rock agreement to the shooting range. Motion by Bob Brown and seconded by Monday to approve the following rock agreement: I, High Lakes Outdoor Alliance, agree to pay 50% of the cost of the granular surfacing placed on 130th St. (Sec. 24 Lincoln Twp. & Sec. 19 Dodge Twp.) beginning 740.0 feet east of the Northwest corner Section 19-73-29 thence east for a distance of 0.88 miles. The cost of the initial granular surfacing and grading shall not exceed \$37,955.15. The County Secondary Road Department shall prepare the roadbed and blade the surface prior to placing the granular surfacing. The cost shall include all grading, hauling, blading, brush cutting, and granular surfacing. The road department will not be responsible for the cost of moving any utilities. The property owner will be responsible for providing additional right-of-way if needed, all seeding of the right-ofway, and all cost for the storm water discharge permit good for one year. The Union County Secondary Road Department shall assume all road maintenance responsibilities thereafter. Roll Call Vote: Dennis Brown aye, Bob Brown aye, Jansen aye, Monday aye, and Riley aye. Motion carried. Akes presented and discussed the maintenance and activity report and the purchasing of a used Caterpillar D6N Crawler Tractor. Utility Permit: Motion by Jansen and seconded by Dennis Brown to approve the utility permit with Windstream Communications for placing 2520 feet of 25 pair copper telephone cable and new pedestal at 1143 Ivy Ave, Lincoln Township, Section 9, Maynard Hostetler. All voting aye. Motion carried. Bid Letting: Bids were opened for project number LFM-611-7X-88 from: Cohron AM and Son INC, Atlantic, IA -\$288,153.05. Cunningham- Reis Co., Van Meter, IA-\$276,316.60. Herberger Construction Co INC, Indianola, IA -\$292,368.00. Iowa Bridge and Culvert, LC, Washington, IA- \$311,492.76. Murphy Heavy Construction CORP, Anita, IA-\$298,779.29. Akes will review the bids and bring back for the Board of Supervisors' approval next week. Stop Sign Resolution: Motion by Bob Brown and seconded by Jansen to approve **Resolution # 44 WHEREAS:** The Board of Supervisors is empowered under the authority of Section 321.236, 321.255, and 321.345 of the Code of Iowa to designate any secondary road intersection under their jurisdiction as a STOP intersection and to erect STOP signs at one or more entrances to such intersection, and WHEREAS: At the intersection of Quail Avenue and 170th Street located at the N ¹/₄ corner of Section 10-72-29, Union Township, Union County, Iowa, approaching traffic from the north on Quail Avenue has limited sight distance both east and west. NOW, THEREFORE, BE IT **RESOLVED** by the Union County Board of Supervisors that the southbound traffic approaching from the north on Quail Ave. be designated as a "STOP approach" to the above described intersection. Roll Call Vote: Dennis Brown aye, Bob Brown aye, Jansen aye, Monday aye, and Riley aye. Motion carried. This resolution was passed on the 23rd day of May, 2011. Final Request for Reimbursement: Motion by Dennis Brown and seconded by Monday for the chair to sign the final request for reimbursement on 3 EWP Projects with NRCS. All voting aye. Motion carried. Advancing a bridge project from Fiscal Year 2013 to 2012: Motion by Monday and seconded by Dennis Brown to advance the start date of project BROS-C088(113)-8J-88. All voting ave. Motion carried. Approval of Right of way contracts: Motion by Bob Brown and seconded by Monday to approve the Right of Way contracts with Dennis and Pauline Sweet for \$2650.30 for approximately 0.26 Acres at \$3200.00 per acre and approximately 27.88 rods of new fence at \$48.00 per rod; and Sheryl De Loach, Kathleen Grettenberg, Kim Kiburz, Kurtis Kiburz

for \$2524.99 for approximately 0.30 acres at \$3634.21 per acre approximately 28.08 rods of new fence at \$34.00 per rod. All voting aye. Motion carried.

RENEWAL OF FAMILY ASSISTANCE CONTRACT: Jocelyn Blazek, DECAT Coordinator discussed the fiscal year 2012 pass through grant for \$15,000.00. Motion by Bob Brown and seconded by Jansen to approve the \$15,000.00 contract and pass through agent for the DECAT grant, the County will receive 7%. All voting aye. Motion carried.

CARE: Jana Daily, CARE Coordinator, discussed getting bids for a CARE vehicle, and specified the minimum requirement for the vehicle with the Board of Supervisors. In addition the CARE Taurus is in need of repairs estimated at \$742.00, a brick on the CARE building needs replaced due to a large crack, and another air conditioning vent in the kitchen estimated at \$550.00 was recommended. Daily also discussed some sidewalk areas needing repair.
