## REGULAR SESSION

The Union County Board of Supervisors met in regular session on Monday, August 22, 2011. The meeting was called to order at 9:00 AM with the following members present: Bob Jansen, Dennis Brown, Bob Brown, Lois Monday and Ron Riley.

**AGENDA:** Motion by Monday and seconded by Dennis Brown to approve the Agenda. All voting aye. Motion carried.

**MINUTES:** Motion by Jansen and seconded by Bob Brown to approve the minutes from August 15, 2011. All voting aye. Motion carried.
