## **SEPTEMBER 12, 2011**

The Union County Board of Supervisors met in regular session on Monday, September 12, 2011. The meeting was called to order at 9:00 AM with the following members present: Bob Jansen, Dennis Brown, Bob Brown, Lois Monday and Ron Riley.

**EAST GRAND RIVER WATERSHED:** Motion by Bob Brown and seconded by Jansen to extend the completion date on the East Grand River Watershed, project agreement number 69-6114-9-68, to November 30, 2011, per discussion and recommendation by Paul Goldsmith from the NRCS Office.
