The agreement is to doze the fence line with tree and brush removal on the North side of the road beginning at the Southeast corner in Section 13 Township 71 Range 30 (Grant Township) (250<sup>th</sup> Street) Thence West 427.0 feet, a distance of .08 miles, also on the East side of the road beginning 800.0 feet North of the Southwest corner, Section 13-71-30 (Grant Township) (Lark Ave), thence North 1749.0 feet a distance of .33 miles. Mr. Ehm also discussed litter that has been thrown in a ditch south of his property that needs to be removed.
