**MINUTES:** Motion by Bob Brown and seconded by Jansen to approve the December 19, 2011 Minutes. All voting aye. Motion carried.

**SUPERVISOR PLAN OPTION RESOLUTION:** Motion by Dennis Brown and seconded by Monday to approve Resolution # 13 **NOW** on this 28<sup>th</sup> day of December, 2011 the Union County Board of Supervisors defines UNION COUNTY as a "Plan 1" Supervisor County. **WHEREAS** a candidate for supervisor can reside anywhere in UNION COUNTY and are voted on at-large pursuant to Iowa Code 331.206. **WHEREAS** the matter of the reduction of 5 Supervisors to 3 Supervisors has been approved by vote of the public, without designation of Plan of Organization, and **WHEREAS** no petition for designation of a Plan of Organization was presented, and **WHEREAS** the Union County Board of Supervisors is authorized by statute, Iowa Code 331.206 (2) (a), to designate the Plan of Organization, **BE IT THEREFORE RESOLVED** in preparation for the "Plan 1" effective date of the 1<sup>st</sup> day of January, 2013, the supervisor candidates for the 2012 Primary and General Election will be held to the "Plan 1" requirements with no residential restrictions within UNION COUNTY. Candidate for the 2012 Primary and General Election will be voted on at-large.

**BE IT FURTHER RESOLVED** that there will be a race for a 2 Year Term and a race for a 4 Year Term on both the 2012 Primary Republican and Democratic Ballot and on the 2012 General Election Ballot.

**BE IT FURTHER RESOLVED** that the Union County Board of Supervisors may not make any additional changes to the Plan of Organization for at least 6 (six) years pursuant to lowa Code 331.206 (2) (a).
