The Union County Board of Supervisors met in regular session on Monday, July 16, 2012. The meeting was called to order at 9:00 AM with the following members present: Bob Jansen, Dennis Brown, Ron Riley, and Bob Brown. Lois Monday was absent.

**AGENDA:** Motion by Riley and seconded by Jansen to approve the Agenda. All voting aye. Motion carried.

**MINUTES:** Motion by Dennis Brown and seconded by Jansen to approve the July 9, 2012 Minutes. All voting aye. Motion carried.

**OPEN FORUM:** No one spoke during open forum.

**CPC MENTAL HEALTH REDISTRICTING:** Lori Nosekabel discussed the Mental Health Redistricting that was passed by the State Legislators. **Community and Family Resources Amendment:** Motion by Jansen and seconded by Riley for the chair to sign the Community and Family Resources Amendment. All voting aye. Motion carried.

**COUNTY ENGINEER:** Steve Akers, County Engineer, presented and discussed the maintenance activity report and the weed spraying map. Akers also discussed the closing of a bridge on 197<sup>th</sup> Street and the Farm-to-Market road changes near Cromwell and Afton. **Utility Permit Application:** Motion by Riley and seconded by Dennis Brown to approve the Utility Permit Application with Southern Iowa Rural Water to install a rural water line in Section 6 of Spaulding Township for a new hog building. All voting aye. Motion carried. **Utility Permit Application:** Motion by Jansen and seconded by Dennis Brown to approve the Utility Permit Application with Windstream Communications for placing 1600 foot of 12 pair copper telephone cable along Pheasant Ave in Section 15 and 16 in Sandcreek Township for a new house at 2426 Pheasant Ave. All voting aye. Motion carried. **Tile Permit:** Motion by Riley and seconded by Jansen to approve the tile line permit for Vernon Long to bore under the road near Kingfisher Avenue in Section 3 of Grant Township. All voting aye. Motion carried.

**HR SERVICES:** Renee VonBrokern, Von Brokern Associates from Urbandale, IA, discussed HR and negotiation services that she could provide for Union County.

**HOMESTEAD AND MILITARY ALLOWANCES:** Motion by Jansen and seconded by Dennis Brown to approve 168 Homestead and Military Allowances. All voting aye. Motion carried.

**HOMESTEAD AND MILITARY DISALLOWANCES:** Motion by Dennis Brown and seconded by Riley to approve 178 Homestead and Military Disallowances. All voting aye. Motion carried.

**CLERK'S REPORT:** Motion by Riley and seconded by Dennis Brown to accept the clerk's report for June in the amount of \$1281.25. All voting aye. Motion carried.

**SUSPENDED TAX LIST:** Motion by Dennis Brown and seconded by Riley to approve the persons who, per the Department of Human Services, still meet the requirements of continued eligibility for suspended taxes from the current tax billing, per Iowa Code Section 427.9. All voting aye, motion carried.
