

Regular Session

June 10, 2019

The Union County Board of Supervisors met in Regular Session on Monday June 10, 2019. The meeting was called to order at 9:00 AM with the following members present: Ron Riley, Rick Friday and Dennis Brown.

AGENDA: Motion by Friday and seconded by Riley to approve the Agenda. All voting aye, motion carried.

MINUTES: Motion by Friday and seconded by Riley to approve the minutes from June 3, 2019. All voting aye, motion carried.

OPEN FORUM: Michael and Sharon McCullough and Pamela McKeown expressed concerns on Adams St, Dogwood St, REA Rd and 170th St.
