General County Services - \$3,260,412

Rural County Services - \$1,046,242

The Maximum Property Tax dollars requested in either General County Services or Rural County Services for FYR 21-22 does not represent an increase of 102% from the Maximum Property Tax dollars requested for FYR 20-21. Roll call vote: Brown aye, Friday aye, Riley aye, motion carried.
