

REGULAR SESSION

JULY 6, 2021

The Union County Board of Supervisors met in Regular Session on Tuesday July 6, 2021. The meeting was called to order at 9:00AM with the following members present: Ron Riley, Dennis Brown and Rick Friday.

AGENDA: Motion by Friday and seconded by Brown to approve the agenda. All voting aye, motion carried.

MINUTES: Motion by Brown and seconded by Friday to approve the minutes from June 28, 2021. All voting aye, motion carried.

OPEN FORUM: No one spoke at open forum.

SECONDARY ROADS: Keith Wieland, Union County Assistant Engineer presented and discussed the weekly maintenance activity report. **Stipend Removal/Wage Adjustment:** Motion by Friday and seconded by Brown to remove the stipend for Chad Needham and set a new hourly wage of \$23.26 starting the July 15th pay date as recommended by Union County Assistant Engineer, Keith Wieland. All voting aye, motion carried. Motion by Brown and seconded by Friday to remove the stipend for Al Hysell and set a new annual wage of \$69,992.00 starting July 15th pay date as recommended by Union County Assistant Engineer, Keith Wieland. All voting aye, motion carried. **Maintenance Foreman 1:** Motion by Friday and seconded by Brown to approve Tom Day as Maintenance Foreman 1 as recommend by Union County Assistant Engineer, Keith Wieland. All voting aye, motion carried. **Resolution #1 FY 21-22 – Bridge for Closure and Load Postings:** Motion by Brown and seconded by Friday to approve Resolution #1 FY 21-22 as follows: WHEREAS Union County bi-annually completes an inspection of all bridges on Secondary Road System of Union County and WHEREAS, part of this inspection involves the recalculation of the safe load capacity of any structure showing remarkable deterioration of the structural components of that structure and WHEREAS, that structural evaluation has resulted in the recommendation to reduce the safe load capacity that can be supported by certain structures, NOW, THEREFORE BE IT RESOLVED by the Union County Board of Supervisors on this 6th day of July, 2021 as provided in Sections 321.47, 321.472 and 321.473, Code of Iowa to erect/or maintain weight limit signs in advance of following bridges located on the Federal Aid, Farm-to-Market, and Local Secondary Road Systems. (See Deficient Bridge Notification List at Secondary Roads Office). Roll call vote: Brown aye, Friday aye, Riley aye, motion carried. **Utility Permit:** Motion by Friday and seconded by Brown to approve the Utility Permit Application from Clarke Electric Cooperative, Inc. to bore (1) 2 ½” duct with (1) 7.2 KV to ground electric cable on 230th Street. All voting aye, motion carried.
