WHEREAS, nonfederal entities and contractors are subject to debarment and suspension regulations implementing EO 12549, EO 12689 at CFR Part 180 and 2 CFR part 180. Whereas Federal Signal is not identified debarred. WHEREAS, payment for services shall be conducted upon approved inspection of all work. Whereas, any changes to this contract shall be completed in writing and agreed upon by both parties. NOW, THEREFORE, IT IS RESOLVED by the Board of Supervisors of Union County, Iowa, approves the attached statement of work contract with Federal Signal to purchase and install an outdoor warning siren and all attachments thereto for a turnkey solution as per contract documents.
