Procurement by Micro-Purchase Procedures as follows: Micro-Purchases are purchase of supplies and or services using "Simplified Acquisition Procedures", the aggregate amount which does not exceed the micro-purchase threshold of \$15,000 (was \$3,000) as set in Federal Acquisition Regulation at 2 CFR 200.67. To the extent practicable, the Union County Board of Supervisors, must distribute micro-purchases equitably among qualified suppliers. Micro-purchases may be awarded without soliciting competitive quotations if the agency considers the price to be reasonable. All micro-purchases greater than \$500 must be approved by the Union County Board of Supervisors. Purchases of less than \$500 may be made, without prior approval, by the coordinator, if such purchases lie within the coordinator's normal scope of work. All voting aye, motion carried.

SECONDARY ROADS: Union County Roads Superintendent, Al Hysell, presented and discussed the weekly maintenance report.
