

**REGULAR SESSION**

**July 11, 2022**

The Union County Board of Supervisors met in Regular Session on Monday July 11, 2022. The meeting was called to order at 9:00AM with the following members present; Rick Friday and Dennis Brown. Ron Riley was absent.

**AGENDA:** Motion by Friday and seconded by Brown to approve the agenda. All voting aye, motion carried.

**MINUTES:** Motion by Friday and seconded by Brown to approve the minutes of July 5, 2022. All voting aye, motion carried.

**OPEN FORUM:** No one spoke in open forum.

**SECONDARY ROADS:** Union County Roads Superintendent, Al Hysell, presented and discussed the weekly maintenance activity report

**RESOLUTION #3 – CONSERVATION TRUST TRANSFER:** Motion by Friday and seconded by Brown to approve Resolution #3 – Conservation Trust Transfer as follows: Now on this 11<sup>th</sup> day of July 2022, the matter of an operating transfer comes before the Union County Board of Supervisors. WHEREAS, it is desired to transfer monies from the Conservation Trust Fund (0027) to the Conservation Capital Project Fund (1510), and WHEREAS, said operating transfer is in accordance with Section 331.432 of the Code of Iowa. BE AND IT IS HEREBY RESOLVED that the sum of \$880.00 is ordered to be transferred from the Trust Fund (0027) to the Conservation Capital Projects fund (1510) effective this 11<sup>th</sup> day of July. The Auditor is directed to correct her books accordingly, and to notify the Treasurer of this operating transfer accompanying the notification with a copy of this resolution and the record of its adopting. Roll call vote: Friday aye, Brown aye, Riley absent, motion carried.

**CLERK’S REPORT:** Motion by Friday and seconded by Brown to accept the Clerk’s monthly report as presented by Union County Auditor, Sandy Hysell. All voting aye, motion carried.

**RESOLUTION #2 – CLERK/TOWNSHIP QUESTION ON GENERAL ELECTION BALLOT:** Motion by Friday and seconded by Brown to approve Resolution #2 – Clerk/Township question on the General Election Ballot as follows: WHEREAS, it is frequently difficult to fill the position of Township Trustees and Clerk at the general election; and WHEREAS, the Iowa Legislature has amended Iowa Code Section 39.22 to permit the Board of Supervisors to fill the offices of Township Trustee and Clerk by appointment; and WHEREAS, the County Commissioner of Elections is to submit the question to the eligible voters of the Township at the next general election: NOW, THEREFORE BE IT RESOLVED by the Supervisors of Union County that the Union County Commissioner of Elections is hereby directed to submit the question whether the offices of Township Trustee and Clerk shall be filled by appointment by the Board of Supervisors, to the eligible voters of Pleasant Township at the next general election which form would be substantially as follows:

**Should the County Board of Supervisors fill the offices of Township Trustees and Clerk within Pleasant Township by appointment of the Board? YES or NO.**
