

REGULAR SESSION

JULY 25, 2022

The Union County Board of Supervisors met in Regular Session on Monday July 25, 2022. The meeting was called to order at 9:00AM with the following members present; Rick Friday, Ron Riley and Dennis Brown.

AGENDA: Motion by Riley and seconded by Friday to approve the agenda. All voting aye, motion carried.

MINUTES: Motion by Friday and seconded by Riley to approve the minutes of July 18, 2022. All voting aye, motion carried.

OPEN FORUM: No one spoke in open forum.

SECONDARY ROADS: Union County Roads Superintendent, Al Hysell, presented and discussed the weekly maintenance activity report. **Resolution #4 FYR 22/23 – Participation in SS4A Grant Application:** Motion by Friday and seconded by Riley to approve Resolution #4 FYR 22/23 – Participation in SS4A Grant Application as follows: WHEREAS, as part of the new Federal Transportation Bill, Infrastructure Investment and Jobs Act (IIJA), there is over \$1B of roadway safety funding available in the form of Safe Streets and Roads for All (SS4A) grants. To be an eligible applicant for this new safety funding, a county MUST have an eligible Action Plan in place; and WHEREAS, the Iowa County Engineers Association (ICEA) plans to apply for a SS4A grant to develop and supply all 99 counties to participate in this grant application; and WHEREAS, the Union County Board of Supervisors will commit to achieve significant declines in roadway fatalities and serious injuries in Union County; and WHEREAS, the Union County Board of Supervisors recognizes the Action Plan and will assist the County Engineer’s department in achieving the goal of a dramatic decrease in roadway fatalities and serious injuries and zero roadway fatalities and serious injuries by the years 2030 and 2050, respectively; and WHEREAS, the Union County Board of Supervisors, after consulting with the Union County Engineer, desires to participate in a joint SS4A grant to develop and receive an eligible Action Plan for Union County. THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF UNION COUNTY that this County does hereby request to be included in the statewide SS4A grant to develop Actions Plans for all 99 counties in Iowa.
