

**REGULAR SESSION**

**August 22, 2022**

The Union County Board of Supervisors met in Regular Session on Monday August 22, 2022. The meeting was called to order at 9:00AM with the following members present; Rick Friday, Ron Riley and Dennis Brown.

**AGENDA:** Motion by Brown and seconded by Riley to approve the agenda, with the amendment of adding discussion of Waste Management Recycling Contract. All voting aye, motion carried.

**MINUTES:** Motion by Friday and seconded by Riley to approve the August 15<sup>th</sup>, 2022 minutes. All voting aye, motion carried.

**OPEN FORUM:** No one spoke in open forum

**RURAL TAX ABATEMENT:** Board discussed the rural tax abatement on a conference call with Jenna Sabroske, Associate Attorney at Ahlers Cooney in what was needed to move forward with the process.

**HISTORICAL PLACES MATCHING GRANT:** Friday spoke with an owner of a building that is on the National Register and with Berry Bennett, preservation Program Manager of the National Register of Historic Places on the potential restrictions of renovating a building that is on the National Register of Historic Places. After much discussion the board has decided not to proceed with putting the Courthouse on the National Register of Historical Places in Union County, at this time, and will not match the City of Creston’s offer to split the costs associated with applying for the grant.

**OPIOID FUND:** Zach Woods, Director of Public Health and Emergency Preparedness, Mark Shepherd, Union County Sheriff and Shane O’Toole, Union County Attorney, discussed the uses of the Opioid Settlement money that the county has received from the lawsuits filed by the States Attorney General. No decisions were made at this time, until further information has been received.

**WASTE MANAGEMENT:** Brown and Hysell will discuss the options of an extra pick up or putting out another dumpster for cardboard recycling at the Creston location with Waste Management on Tuesday and report back to the board on Monday.

**SECONDARY ROADS:** Union County Roads Superintendent, Al Hysell, presented and discussed the weekly maintenance activity report, and discussed a proposed tree/stump grinding agreement.
