RESOLUTION #20 FYR 22/23 AUTHORIZING AN INTERNAL ADVANCE TO THE GENERAL FUND: Motion by Friday and seconded by Riley to approve Resolution #20 FYR 22-23 Authorizing an Internal Advance to the General Fund as follows: WHEREAS, the County of Union, Iowa ((the "County"), has established the Wind Turbine Urban Renewal Area (the "Urban Renewal Area") and has established the Wind Turbine Urban Renewal Area Tax Increment Revenue Fund (the "Tax Increment Fund") in connection therewith; and WHEREAS, the County has undertaken urban renewal projects (the "Projects") within the Urban Renewal Area and the immediate costs for said Projects are as follows: 1. Set Up of Urban Renewal cost. Invoices total as follows for the period August 2022 through November 2022: General Fund - \$3,08. WHEREAS, in order to make the costs of the Projects eligible to be paid from future incremental property tax revenue, it is necessary to facilitate internal advances of funds: NOW, THEREFORE, IT IS RESOLVED by the Board of Supervisors of the County of Union, Iowa, as follows: SECTION 1. It is hereby directed that an amount not to exceed Three Thousand Eighty-Five dollars (\$3,085) that was paid from the County's General Fund (the "General Fund Advance") in order to pay the costs of the Projects. The General Fund Advance (the "Advance") will be repaid to the General Fund, out of future incremental property tax revenue received into the Tax Increment Fund. SECTION 2. A copy of this resolution shall be filled with the office of the County Auditor of Union County, Iowa to evidence the Advances. Pursuant to Section 403.19 of the Code of Iowa, the County Auditor is hereby directed to certify, no later than December 1, 2022 the original, aggregate amount of the Advances as provided for herein. SECTION 3. All resolutions or parts thereof in conflict herewith, are hereby repealed, to the extent of such conflict. PASSED AND APPROVED this 28th day of November, 2022.
