## **REGULAR SESSION**

The Union County Board of Supervisors met in Regular Session on Monday January 23, 2023. The meeting was called to order at 9:00AM with the following members present; Rick Friday, Dennis Hopkins and Dennis Brown.

**AGENDA:** Motion by Hopkins and seconded by Brown to approve the agenda. All voting aye, motion carried.

**MINUTES:** Motion by Brown and seconded by Hopkins to approve the minutes of January 16<sup>th</sup>, 2023. All voting aye, motion carried.

**OPEN FORUM:** No one spoke in open forum.

**TRANSIT (SIT):** Leesa Lester, Transit Director SIT, presented and discussed what the funding is used for and requesting \$16,935 for fiscal year 23-24 an increase of \$435.

**CROSSROADS:** Brittany Palmer, Executive Director Crossroads Behavioral Health Services, discussed what some of the Crossroad's programs could do for the community with the Opioid Settlement funds that the County has received so far. Palmer's request is for startup funds of \$15,000 for the Reconnecting Youth Program and \$12,000 for the Towards No Drug Use Program.

**SOUTHERN IA RESOURCE CONSERVATION & DEVELOPMENT:** Michelle Wilson, Executive Director Southern Iowa Resource Conservation & Development, presented and discussed the projects that have taken place in Union County and requested \$5,000 for Fiscal Year 23-24, \$1,000 increase from Fiscal Year 22-23.

**MATURA:** Danna Buls, Executive Director Matura, presented and discussed the services/programs that are provided to the Union County residents. Bul's request is \$8,000 for Fiscal Year 23-24 General Assistance, which is a contracted fee between Matura and the County (same as last fiscal year 22-23) and a \$10,000 Fiscal Year 23-24 funding request for Matura which is a \$1,000 increase from Fiscal Year 22-24.

**AFTON DEVELOPMENT CORP:** Mary Hill and Retta Ripperger, Afton Development Corp, presented and discussed the purpose of the Afton Development Corp to improve, develop, promote, advance and expand existing industrial, commercial and professional enterprises in the territory surrounding the City of Afton within Union County. The group is asking for \$5,000 for Fiscal Year 23-24, this is a new funding request.

**ENGINEER:** Christian Boehmer, Union County Engineer, presented and discussed the Secondary Roads and Vegetation Management Fiscal Year 23-24 budget request. Vegetation Management request is \$319,140 which is an increase of \$25,800 from Fiscal Year 22-23. Secondary Roads request is \$5,266,900 which is an increase of \$317,300 from Fiscal 22-23. Al Hysell, Union County Roads Superintendent, presented and discussed the weekly maintenance activity report.

**CARE LEASE AND MANAGEMENT AGREEMENT:** Motion by Hopkins and seconded by Brown to table the signing of the CARE Lease and Management Agreement till next week. All voting aye, motion carried.

**TREASURER:** Union County Treasurer, Kelly Busch, presented and discussed the Fiscal Year 23-24 budget request of \$388,886, which is an increase of \$6,569 from Fiscal Year 22-23.

**BEACON SITE UPDATE:** Mindy Schaefer, Union County Assessor, showed the board the Beacon Site update with all of new add ones that was paid for with the ARPA funds.
