

**REGULAR SESSION**

**February 13, 2023**

The Union County Board of Supervisors met in Regular Session on Monday, February 13, 2023. The meeting was called to order at 9:00AM with the following members present; Rick Friday, Dennis Hopkins and Dennis Brown.

**AGENDA:** Motion by Brown and seconded by Hopkins to approve the agenda. All voting aye, motion carried.

**MINUTES:** Motion by Hopkins and seconded by Brown to approve the minutes of February 6, 2023. All voting aye, motion carried.
