**CARE LEASE AND MANAGEMENT AGREEMENT:** Motion by Brown and seconded by Hopkins to table the signing of the CARE Lease and Management Agreement till next week. All voting aye, motion carried.

**SCANNING SOFTWARE – TYLER TECH AGREEMENT:** Motions by Hopkins and seconded by Brown to approve the Scanning Software agreement with Tyler Tech and for \$47,140, half of the funds coming out of ARPA and the rest from the Treasurer's and Auditor's Budget. All voting aye, motion carried.

RESOLUTION #28 FYR 22/23 – BUDGET DIRECTOR: Motion by Brown and seconded by Hopkins to approve Resolution #28 FYR 22/23 – Budget Director as follows: WHEREAS, the Union County Board of Supervisors requires assistance in preparing the Union County Budget pursuant to Iowa Code Section 331.434. WHEREAS, the Union County Board of Supervisors have determined Sandy Hysell, the currently elected Union County Auditor; has the requisite expertise and experience to assist them with preparation of the Union County Budget pursuant to Iowa Code Section 331.434. WHEREAS, Sandy Hysell desires to assist the Board of Supervisors in preparing the Union County Budget pursuant to Iowa Code Section 331.434 in return for a wage that was set by the Union County Compensation Board. THEREFORE, be it resolved by the Union County Board of Supervisors designate their duties to prepare and adopt a budget pursuant to Iowa Code Chapter 331.434 to Sandy Hysell beginning July 1, 2023 Compensation shall be allocated to Sandy Hysell upon certification of the budget to the Iowa Department of Management. Ide presented the Board a petition with approximately 300 signatures requesting a 2-year abeyance be put in place immediately on all industrial wind power projects at any stage of planning and development within Union County.

Motion by Friday and seconded by Hopkins to put an abeyance on the current Wind Turbine Ordinance for 3 months (April 10<sup>th</sup>, 2023 end date) and no permits/applications will be processed, until all information provided has been reviewed. All voting aye, motion carried.
