

**REGULAR SESSION**

**JUNE 12,2023**

The Union County Board of Supervisors met in Regular Session on Monday June 12, 2023. The meeting was called to order at 9:00AM with the following members present, Dennis Hopkins, Dennis Brown and Rick Friday.

**AGENDA:** Motion by Hopkins and seconded by Brown to approve the agenda. All voting aye, motion carried.

**MINUTES:** Motion by Brown and seconded by Hopkins to approve the minutes from June 5, 2023. All voting aye, motion carried.

**OPEN FORUM:** Lois Olson family with property in the area of Spaulding inquired about a vacated county road adjacent to the Olson’s properties. Dale Cline asked about county owned property in the Kent area.
