

**REGULAR SESSION**

**March 11, 2024**

The Union County Board of Supervisors met in Regular Session on Monday March 11, 2024. The meeting was called to order at 9:00AM with the following members present, Dennis Hopkins, Dennis Brown, and Rick Friday.

**AGENDA:** Motion by Friday and seconded by Brown to approve the agenda. All voting aye, motion carried.

**MINUTES:** Motion by Brown and seconded by Friday to approve the minutes for March 4, 2024. All voting aye, motion carried.

**OPEN FORUM:** No one spoke in open forum.

**MORMON TRAIL PARK:** Jane Briley, Iowa Mormon Trail Association and Angelica Sanchez-Clark, Historical/Partnerships and Outreach Coordinator National Park Services, discussed adding the Mormon Trail Park to the National Park Association and the steps the Mormon Trail Association need to follow.
