Creston Community School District \$29,400,000 General Obligation School Bonds Election

Shall the Board of Directors of the CCSD in the Counties of Adams, Ringgold and Union, State of Iowa, be authorized to contract indebtedness and issue General Obligation Bonds in an amount not to exceed \$29,400,000 to provide funds to construct, furnish and equip an addition to the Elementary/Middle School; to renovate, remodel, repair, improve, furnish and equip portions of the Elementary/Middle School; to renovate, remodel, repair, improve, furnish and equip the Performing Arts area; to construct, furnish and equip an activities addition and improve the site at the High School; and to construct tennis courts and related site improvements?
