REGULAR SESSION

April 29, 2024

The Union County Board of Supervisors met in Regular Session on Monday April 29, 2024. The meeting was called to order at 9:30AM with the following members present, Dennis Hopkins, Dennis Brown, and Rick Friday. Also present from the Creston Community Government Class as follows: Tucker Rohrig

AGENDA: Motion by Brown and seconded by Friday to approve the agenda. All voting aye, motion carried.

MINUTES: Motion by Brown and seconded by Friday to approve the minutes for April 22nd, 2024. All voting aye, motion carried.

OPEN FORUM: No one spoke in open forum.

DECLARATION OF DISASTER: Motion by Friday and seconded by Brown for the chair to sign the Declaration of Disaster as follows: Whereas Union County has suffered from a Tornadic Event (type of incident i.e. disastrous tornado) that occurred on April 26th, 2024, causing severe damage to public and private property, disruption of utility services, and/or endangerment of health and safety of the citizens of Union County within the disaster area. Therefore, the Chairman of the Board of Supervisors, or his designee, has declared a state of emergency, expenditure of emergency funds, and requesting resources and support from community partners and state and federal authorities. Now therefore, LE IT BE KNOWN THAT the Union County Board of Supervisors, pursuant to the authorities vested in the Iowa Constitution, and by Iowa Code 331.30 and authorized under Iowa State Statute and will execute the expenditure of emergency funds, the invoking of mutual aid agreements, and application to the State of Iowa for assistance.

SECONDARY ROADS: Union County Roads Superintendent, Al Hysell, presented and discussed the weekly Maintenance Activity Report.

HOMESTEAD/MILITARY; FAMILY FARM AND HOMESTEAD EXEMPTION CREDIT ALLOWANCES: Motion by Friday and seconded by Brown to approve the Homestead/Military, Family Farm and Homestead Exemption Credit Allowances as presented by Union County Auditor, Sandy Hysell. All voting aye, motion carried.

HOMESTEAD/MILITARY AND FAMILY FARM CREDIT DIS-ALLOWANCES: Motion by Brown and seconded by Friday to approve the Homestead/Military and Family Farm Credit Dis-Allowances as presented by Union County Auditor, Sandy Hysell. All voting aye, motion carried.

LETTER OF RESIGNATION: Motion by Friday and seconded by Brown to accept the resignation letter as of May 25th, 2024, with regret, from Union County Veteran's Affairs Director, Kevin Provost. All voting aye, motion carried.

RESOLUTION #17 FYR 23/24 — AUTHORIZING THE PARTIAL REDEMPTION OF OUTSTANDING GENERAL OBLIGATION URBAN RENEWAL AND REFUNDING BONDS SERIES 2017 DATED AUGUST

22, 2017: Motion by Brown and seconded by Friday to approve Resolution #17 Fiscal Year 23/24 -Authorizing the partial redemption of outstanding General Obligation Urban Renewal and Refunding Bonds Series 2017 - Dated August 22, 2017 as follows: WHEREAS, the County did by resolution dated August 7, 2027, authorized the issuance of #3,000,000 General Obligation Urban Renewal and Refunding Bonds, Series 2017, (the "Bonds") dated August 22, 2017; and WHEREAS, the Bonds are redeemable in any order of their numbering on June 1, 2024 or any date thereafter upon giving notice in the manner provided in the resolution authorizing the issuance of the Bonds; and WHEREAS, it is deemed necessary and advisable that \$285,000be so redeemed on June 1, 2024 and notice redemption be given according to the terms of the resolution authorizing issuance of the Bonds. NOW, THEREFORE, BE IT RESOLED BY THE BOARD OF SUPERVISORS OF UNION COUNTY, STATE OF IOWA: Section 1. The outstanding General Obligation Urban Renewal and Refunding Bonds, dated August 22, 2017, in the principal amount of \$285,000, be and the same are hereby redeemed as of June 1, 2024. Section 2. The Registrar and Paying Agent, UMB Bank, N.A., in its capacity as assignee of and successor to Bankers Trust Company, is hereby authorized and directed to cause notice of such redemption be given not less than thirty (30) days prior to the redemption date and to cause notice of redemption to be mailed to the registered owners of the Bonds by registered mail, and to notify DTC. Section 3. The County Treasurer is hereby authorized and directed to cause to be deposited in a separate fund sum sufficient to pay all principal and interest on the redeemed Bonds to the date of redemption and to notify the County's dissemination agent to post the Notice of Redemption to the MSRB's website (EMMA) in searchable PDF format for the refunded Bonds in accordance with the Continuing Disclosure Certificate for the Bonds. Section 4. That the form of such notice be substantially as follows:
