The Union County Board of Supervisors met in Regular Session on Monday May 20, 2024. The meeting was called to order at 9:04 AM with the following members present, Dennis Hopkins, Dennis Brown and Rick Friday.

AGENDA: Motion by Friday and seconded by Brown to approve the agenda. All voting aye, motion carried.

MINUTES: Motion by Brown and seconded by Friday to approve the minutes for May 13th, 2024. All voting aye, motion carried.

OPEN FORUM: Dale Cline discussed mud running on the dirt roads and asked if the Board would look at the possibility of an Ordinance in charging the people when caught tearing up the dirt roads. Hopkins read a thank you note from Midwest Health for helping move the residents and relocating them to a safe facility after the tornado hit Homestead of Creston.
