The Union County Board of Supervisors met in Regular Session on Monday August 12th, 2024. The meeting was called to order at 9:00AM with the following members present, Dennis Hopkins, Dennis Brown, and Rick Friday.

**AGENDA:** Motion by Friday and seconded by Brown to approve the agenda. All voting aye, motion carried.

**MINUTES:** Motion by Brown and seconded by Friday to approve the minutes for August 5th, 2024. All voting aye, motion carried.

**OPEN FORUM:** No one spoke in open forum.
