## **REGULAR SESSION**

## **DECEMBER 09, 2024**

The Union County Board of Supervisors met in Regular Session on Monday, December 09, 2024. The meeting was called to order at 9:00 AM with the following members present, Dennis Hopkins, Dennis Brown, and Rick Friday. Also present from the Creston Community School Government Class were as follows: Teagen Miller, Justin Best and Drake Pendegraft.

**AGENDA:** Motion by Friday and seconded by Brown to approve the agenda. All voting aye, motion carried.

**MINUTES:** Motion by Brown and seconded by Friday to approve minutes from December 2<sup>nd</sup>, 2024. All voting aye, motion carried.

**OPEN FORUM:** No one spoke in open forum.

**RESOLUTION #9 FYR 24/25 – LAND ACQUISITION POLICY:** Motion by Brown and seconded by Friday to approve Resolution #9 FYR 24/25 – Land Acquisition Policy as follows: WHEREAS on the 9<sup>th</sup> day of December 2024 the Union County Board of Supervisors has established a new Real Estate Acquisition Policy for FY 25. <u>REAL ESTATE</u>: The current average assessed valuation of Real Estate in Union County is \$762.40 per acre. Current market value of Real Estate in Union County is \$6,755.00 per acre: \$6,755.00/\$762.40=8.86

Our factor of 8.86 was assessed evaluation for the true selling price for bare land in Union County with a factor of 1.5 times the assessed valuation for acquisition of real estate for borrow projects. <u>FENCING</u>: Based upon a recent quotation, a barbed wire fence would cost \$37.50 to construct. Recommendation of \$37.50 per rod for barbed wire and \$47.40 per rod for woven wire fence. In addition, each owner is entitled to an additional \$200.00 per interior corner that he/she is required to build of irregularities in the right-of-way purchases lines. **AWARD & SIGN STABLIZATION PROJECT:** Three bids were received from the following: Iowa Earth Works, Moyna D.J & Sons LLC and Jay-R Corp. Motion by Brown and seconded by Friday to award the project to Iowa Earth Works for \$475,338.00 which money from the Farm to Market Funds will be used. All voting aye, motion carried.

All voting aye, motion carried. **Grading Agreement:** Motion by Brown and seconded by Friday to approve the grading agreement between Union County and Ron Cheers for ditching along with dozing the fence line with tree and brush removal located north of 255<sup>th</sup> St, Section 19 of Pleasant Township. All voting aye, motion carried.
