REGULAR SESSION

JANUARY 6, 2025

The Union County Board of Supervisors met in Regular Session on Monday, January 6, 2025. The meeting was called to order at 9:00 AM with the following members present, Dennis Hopkins, Rick Friday and Dennis Brown. Also present from the Creston Community School Government Class as follows: Parker Varner, Justin Loudon, Rici Hampton, Sydney Strunk and Mia Strunk

ELECTION OF CHAIR: Motion by Friday and seconded by Hopkins to appoint Brown as chair of the board. All voting aye, motion carried.

ELECTION OF VICE-CHAIR: Motion by Hopkins and seconded by Brown to appoint Friday as vice-chair of the board. All voting aye, motion carried.

RESOLUTION #12 FYR 24/25-CONSTRUCTION EVALUATION (MASTER MATRIX): Motion by Hopkins and seconded by Friday to approve Resolution #12 FYR 24/25-Construction Evaluation (master Matrix) as follows: WHEREAS, Iowa Code section 459.304(3) sets out the procedure if a board of supervisors wishes to adopt a "construction evaluation resolution" relating to the construction of a confinement feeding operation structure; and WHEREAS, only counties that have adopted a construction evaluation resolution can submit to the Department of Natural Resources (DNR) an adopted recommendation to approve or disapprove a construction permit application regarding a proposed confinement feeding operation structure; and WHEREAS, only counties that have adopted a construction evaluation resolution and submitted an adopted recommendation may contest the DNR's decision regarding a specific application; and WHEREAS, by adopting a construction evaluation resolution the board of supervisors agrees to evaluate every construction permit application for a proposed confinement feeding operation structure received by the board of supervisors between February 1, 2025 and January 31, 2026 and submit an adopted recommendation regarding that application to the DNR; and WHEREAS, the board of supervisors must conduct an evaluation of every construction permit application using the master matrix created in Iowa Code section 459.305, but the board's recommendation to the DNR may be based on the final score on the master matrix or may be based on reasons other than the final score on the master matrix; NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF UNION COUNTY that the Board of Supervisors hereby adopts this construction evaluation resolution pursuant to Iowa Code section 459.304(3). The participating employee shall be authorized to sell, assign and endorse for transfer certificates representing stocks, bonds or other securities now registered or hereafter registered as a result of participating in the Union County IA 457 Deferred Compensation Plan. I, Dennis Brown, Chairman of the Union County Board of Supervisors, established under the laws of the State of Iowa, hereby certify that the foregoing is a true copy of a resolution duly adopted by the Board of Supervisors of said County in Iowa, at a meeting duly held the 3rd day of January,2024, at which a quorum was present and voting, and that the same has not been repealed or amended, and remains in full force and effect.
