

## REGULAR SESSION

**JANUARY 14, 2026**

The Union County Board of Supervisors met in Regular Session on Wednesday January 14, 2026, at 9:00AM, with the following Board members present, Dennis Hopkins, Rick Friday and Dennis Brown attended by speaker phone.

**AGENDA:** Motion by Hopkins and seconded by Brown to approve the agenda. All voting aye, motion carried.

**MINUTES:** Motion by Hopkins and seconded by Brown to approve minutes from Wednesday, January 7, 2025. All voting aye, motion carried.

**OPEN FORUM:** No comments were made in open forum.

**CARE:** Two bids were received for the repair for a sewer line for CARE building located in Afton, from the building to the manhole as follows: Hoffman Communications and H&H Commercial Services. Motion by Hopkins and seconded by Brown to accept the bid from Hoffman Communications for \$1,550.00. All voting aye, motion carried.

**SOUTHERN IOWA TROLLEY:** Leesa Lester, Transit Director-Southern Iowa Trolley discussed the Fiscal Year 26/27 Funding request of \$19,347 and discussed rides provided in Union County.

**UNION COUNTY TOURISM:** Olivia Cheers, Executive Director-Creston Chamber of Commerce discussed the Fiscal Year 26/27 Funding request of \$5,000.

**HISTORICAL SOCIETY:** Dick Anderson & Steve Francis discussed last year's expenses and future plans for the Historical Site. The fiscal year 26/27 funding request, \$6,500, same as last fiscal year.

**COMPENSATION BOARD:** Renee Hoyt and Drew Henderson, Compensation Board Representative, presented and discussed the compensation board recommendation for the Elected Officials increase for Fiscal Year 26/27 as follows: Sheriff 8%, Attorney 6%, Recorder 6%, Treasurer 6%, Auditor 6%, Supervisors 4% and no change to the budget director wage of \$3,500.

**MATURA:** Dana Buls, Executive Director-Matura Action Corporation, discussed the fiscal year 26/27 funding request. Buls discussed and presented services that are provided in the County and an annual report for the last fiscal year. Fiscal Year 26/27 funding request, MATURA \$10,000 and General Assistance Contracted Fee \$8,000.00, same as 25/26 Fiscal Year.

**SHERIFF:** Motion by Hopkins and seconded by Brown to acknowledge the hiring of Isaias Ramos as new Jail employee starting Monday, January 19<sup>th</sup>, 2026, with a starting wage of \$24.91. All voting aye, motion carried.

**ENGINEER:** Motion by Hopkins and seconded Brown by to approve signing the Plan Set and Road Use Agreement L-HMAOEP—73-01 for Orient Energy Center as presented and discussed by Union County Engineer Christian Boehmer. Roll call vote: Hopkins aye, Brown aye, Friday aye, motion carried

**SECONDARY ROADS:** Union County Roads Superintendent Al Hysell presented and discussed the weekly maintenance activity report. **Fuel Quotes:** Two Fuel quotes for diesel and gas were received as follows: New Coop and FS Agri Vision. Motion by Hopkins and seconded by Brown to approve the fuel quote from FS Agri Vision for a total of \$328, 367. All voting aye, motion carried.

**Employee Hire:** Motion by Hopkins and seconded by Brown to acknowledge the hire of Tyler Miller and Garrett Kalvig with a starting wage of \$21.99 as recommended by County Engineer and Roads Superintendent. All voting aye, motion carried.
