

The Union County Board of Supervisors met in Regular Session on Wednesday, July 22nd, 2026, at 9:00AM, with the following Board members present, Dennis Brown, Dennis Hopkins, and Rick Friday. Chairman Friday called the meeting to order and led the Pledge of Allegiance.
