AGENDA: Motion by Hopkins and seconded by Brown to approve the amended agenda. All voting aye, motion carried.

CLERK OF COURT REPORT: Motion by Hopkins and seconded by Brown to accept the monthly Clerk of Court’s report as presented by Union County Auditor Sandy Hysell. All voting aye, motion carried.

CARE MANAGEMENT AGREEMENT: Motion by Brown and seconded by Hopkins to approve the CARE Management Agreement between Union County, Heartland Management Alliance and William Eadie Residential Services, Inc d/b/a CARE. All voting aye, motion carried.

CARE LEASE AGREEMENT: Motion by Hopkins and seconded by Brown to approve the CARE Lease Agreement between Union County and William Eadie Residential Services, Inc d/b/a CARE. All voting aye, motion carried.

DISCUSSION TO DESIGN A UNION COUNTY FLAG: Board discussed the possibility of having a contest and/or having a local Union County artists do an original design for an updated Union County Flag.
